Subject: Clarification regarding validity of e-passes.

Madam/Sir,

I am directed to refer Delhi Disaster Management Authority (DDMA) Order No. 500 dated 28.12.2021 which inter alia directs that there shall be imposition of Night Curfew on movement of individuals in NCT of Delhi from 10:00 PM to 05:00 AM.

Further DDMA has issued Order No. 504 dated 04.01.2022 regarding imposition of Weekend Curfew on movement of individuals in NCT of Delhi from 10 PM of Friday till 5 AM of subsequent Monday. As per this order, the movement of the individuals for the activities specified as "Essential goods & Services" or "Exempted category" as prescribed in DDMA order No. 460 dated 08.08.2021 have been allowed for movement during Night Curfew and Weekend Curfew with the possession of e-pass (in soft or hard copy) only, which can be obtained by applying on the website www.delhi.gov.in.

In this context, it is clarified that e-pass possessed by a person on or after 04.01.2022 (i.e. from the date of issuance of DDMA order No. 504) for movement connected to "Essential goods & Services" or "Exempted category", shall be valid during the entire period of imposition of Night Curfew as well as Weekend Curfew in NCT of Delhi.

This issues with the approval of Pr. Secretary (Revenue)/Divisional Commissioner.
