

Minutes of the meeting held under the chairmanship of Shri Sanjay Kothari, Secretary, DOPT on 31.07.2015 at 12:00 NOON to consider cases of Inter cadre deputation / inter cadre transfer

A meeting was held under the chairmanship of Shri Sanjay Kothari, Secretary, DOPT on 31.07.2015 at 12:00 Noon to consider cases of Inter cadre deputation / inter cadre transfer / extension. In the meeting, EO&AS and AS(S&V) being members of the Committee were present, besides Director (SK), Director(GM) and US (S-III) were also present to assist the committee in the meeting.

At the outset the Committee reviewed the decision taken on the proposals considered in its previous meeting held on 24.07.2015 and noted with satisfaction, the action taken on these decisions.

Thereafter the Committee took up the proposals placed before it one by one and after detailed deliberations and careful consideration on each case, the following decisions were taken.

Case No.1 Representation for fresh assessment of threat to life and reconsideration of the decision taken on inter cadre transfer of Shri Chinmay Pundlikrao Gotmare , IAS (AM:09) from Assam- Meghalaya cadre to either of Madhya Pradesh, Rajasthan, Gujarat, Chhattisgarh or Telangana. Earlier he has also requested for inter cadre deputation as interim relief.

The Committee considered the representation dated 09.06.2015 of the officer. However, keeping in view the facts that IB Report as well as Government of Meghalaya (parent cadre) had not confirmed the claim of the officer for threat perception, the Committee reiterated its earlier decision **not to recommend** his case for change of cadre. Also the Committee did **not recommended** the case of the officer for **inter cadre deputation** as the officer has not completed required 9 years of service in his parent cadre.

Case No. 2: Pre-mature repatriation of Dr Nidhi Pandey, IAS(MH:01) to her parent cadre viz Maharashtra, presently in Uttarakhand cadre on inter cadre deputation till June 2016.

The Committee, in view of the request of the officer, has agreed to the pre-mature repatriation of Dr. Nidhi Pandey, IAS(MH:01) to her parent cadre. The Committee directed to submit a Note for seeking the approval of ACC accordingly.

Case No.3: Inter cadre deputation of Shri Vinod Sharma, IAS(UP:01) from Uttar Pradesh to Uttarakhand cadre.

The Committee observed that Shri Vinod Sharma is working in the Uttarakhand since 28.11.2012 without the approval of ACC. Further, State Government of Uttar Pradesh has not provided their consent in the matter till date. The Committee felt that it is not a case of inter cadre deputation but it is the case of overstaying without the approval of the competent authority. The Committee directed that the officer may be asked to report back to his parent cadre immediately.

Case No. 4: Inter cadre deputation on Smt. Alaknanda Dayal, IAS (PB:2000) from Punjab cadre to Uttar Pradesh cadre on the grounds of extreme hardship.

The Committee observed that the case is prima facie covered under the extant policy. However, the officer has not mentioned period of deputation. The Committee directed to seek the requisite information from the officer and also the comments of the State Government of Uttar Pradesh and put up the case for the approval of ACC accordingly.

The meeting ended with vote of thanks to the Chair.
