

**Minutes of the meeting held under the chairmanship of Shri Sanjay Kothari, Secretary, DOP&T on 18.01.2016 to consider the cases of inter cadre deputation/ inter cadre transfer / extension in inter cadre requiring relaxation of provision(s) of the guidelines.**

A meeting was held on 18.01.2016 under the Chairmanship of Secretary(P) to consider the cases of inter cadre deputation/ inter cadre transfer / extension in inter cadre deputation period requiring relaxation of provision(s) of the guidelines. The members of the committee EO & AS and AS(S&V) were also present. Further, US(S-III) was also present to assist the Committee in the meeting.

The Committee took note of the Action Taken Report on the minutes of the previous meeting held on 04.01.2016. The Committee after detailed deliberations and careful consideration in each case took following decisions in the meeting:-

**Case I: Inter cadre transfer of Shri Kshitij Singhal, IAS(OR:14) from Odisha cadre to Madhya Pradesh cadre on the grounds of marriage to Ms. Sheetla Patle, IAS (MP:14)**

The Committee was informed that the officer has requested for cadre transfer to Madhya Pradesh cadre on the grounds of marriage to Ms. Sheetla Patle, IAS(MP:14). The home state of the officer is Rajasthan. **The Committee after detailed deliberations directed that on receipt of no objection / consent from respective states, the proposal for cadre transfer of the officer may be put up for the approval of Secretary (P) through EO&AS**

**Case II: Extension of inter cadre deputation period in respect of Smt. Indra Mallo, IAS (MH:99) from Maharashtra cadre to Arunachal Pradesh segment of AGMUT cadre.**

The Committee was informed that the officer would complete 5 years of service in home deputation in North East on 16.10.2016. **The Committee decided not to recommend the proposal as the proposal is not covered under the extant policy.**

**CASE III: Premature repatriation of Shri A. Sreenivas, IAS (HY:04) from Telangana cadre to Haryana cadre (parent cadre).**

The Committee was informed that the State Government of Haryana has requested for premature repatriation of the officer to Haryana on grounds of acute paucity of officers. **The Committee after detailed deliberations directed to seek comments of State Government of Telangana. On receipt of no objection from State Government of Telangana, the proposal along with ACC note for pre mature repatriation of the officer to Haryana may be put up for approval of ACC.**

**Case IV: Cadre change of Ms. K. Radhika Aiyar, IAS (WB:11) on the basis of PH policy dated 14.02.2014.**

The Committee was informed that letter seeking willingness of the officer for cadre change to Uttar Pradesh was sought.
