

**Minutes of the meeting held under the chairmanship of Shri Sanjay Kothari, Secretary, DOP&T on 02.02.2016 to consider the cases of inter cadre deputation/ inter cadre transfer / extension in inter cadre requiring relaxation of provision(s) of the guidelines.**

A meeting was held on 02.02.2016 under the Chairmanship of Secretary (P) to consider the cases of inter cadre deputation/ inter cadre transfer / extension in inter cadre deputation period requiring relaxation of provision(s) of the guidelines. The members of the committee EO & AS and AS(S&V) were also present. Further, US(S-III) was also present to assist the Committee in the meeting.

The Committee took note of the Action Taken Report on the minutes of the previous meeting held on 18.01.2016. The Committee after detailed deliberations and careful consideration in each case took following decisions in the meeting:-

**Case I: Representation for inter cadre transfer by Mr. P. Parthiban, IAS (AGMUT:11) and Ms. Nisha Parthiban, IPS (TN:11) to a common cadre on the grounds of marriage**

The Committee was informed that the officers have requested for cadre transfer to a common cadre on the grounds of marriage. Being a unique case, points to the gaps in the existing policy. Either of the officers can't opt for the cadre of the spouse being their home cadre. The question of refusal by spouse's cadre doesn't arise. **The Committee after detailed deliberation decided that in such cases, a choice to the officers to choose the immediate next cadre opted by the officer in the detailed application form submitted to UPSC below the present cadre allotted may be provided. The Committee further directed to put up the proposal for seeking approval of ACC.**

**Case II: Proposal for change of cadre of Shri Shyam Lal Poonia, IAS (MN:2010) on the grounds of extreme hardship.**

The Committee was informed that the officer has requested for change of cadre on grounds of extreme hardship. **The Committee after detailed deliberations decided not to recommend the proposal of the officer.**

**Case III: Proposal for change of cadre in respect of Shri Shiraz Daneshyar, IAS (WB:14) on the basis of OM dated 14/02/2014 regarding cadre change of IAS appointed against vacancies reserved for PH category.**

The Committee was informed that the officer has requested for cadre change on grounds of PH policy dated 14.02.2014. However, the medical board has not recommended his proposal for cadre change. **The Committee after detailed deliberations decided to defer the proposal.**

**Case IV: Premature repatriation of Shri D. V. Swamy, IAS (OR:2001) from Karnataka cadre to Odisha cadre (parent cadre).**

The Committee was informed that the officer has requested for premature repatriation on personal grounds. **The Committee after detailed deliberations directed that the comments of state Governments of Odisha and Karnataka may be sought and on**

receipt of requisite comments / no objection, the proposal for premature repatriation may be put up for the approval of ACC through MOS(PP).

**Case V: Review of the Policy for inter cadre transfer / deputation for North East cadres**

The Committee discussed the policy for inter cadre transfer / deputation for North East cadres and directed to put up the policy on website as discussed.
