

**Minutes of the meeting held under the chairmanship of Shri Sanjay Kothari, Secretary, DOP&T on 09.03.2016 to consider the cases of inter cadre deputation/ inter cadre transfer / extension in inter cadre requiring relaxation of provision(s) of the guidelines.**

A meeting was held on 09.03.2016 under the Chairmanship of Secretary(P) to consider the cases of inter cadre deputation/ inter cadre transfer / extension in inter cadre deputation period requiring relaxation of provision(s) of the guidelines. The member of the committee AS(S&V) & EO&AS were also present. Further, Director (AIS) & US(S-III) were also present to assist the Committee in the meeting.

The Committee took note of the Action Taken Report on the minutes of the previous meeting held on 03.03.2016. The Committee after detailed deliberations and careful consideration in each case took following decisions in the meeting:-

**Case 1:** Inter cadre transfer of Mr. Samuel Paul N, IAS (NL:2013) from Nagaland cadre to Uttar Pradesh cadre on grounds of marriage to Ms. Divya, IFS (UP:2013).

The Committee was informed that the officer has requested for cadre transfer on grounds of marriage to Ms. Divya, IFS (UP:2013). Further, the home state of the officer is "Tamil Nadu" as per CSE 2012. **The Committee after detailed deliberations recommended the proposal and directed to seek comments of the State Government of Nagaland and Uttar Pradesh and vigilance status of the officer. Thereafter, on receipt of no objection from the concerned Governments, the proposal may be put up for approval of Secretary (P) through EO &AS.**

**Case 2:** Inter cadre deputation of Shri Ashish Bhargava, IAS(MP:2012) from Madhya Pradesh cadre to Rajasthan cadre.

The Committee was informed that the officer has requested for inter cadre deputation on grounds of ill health of parents. Further, it was also informed that the officer has not completed the required 9 years of service in his cadre. **The Committee after detailed deliberations did not recommend the case as the same is not covered under the existing policy and expressed strong displeasure of receiving such kind of request from the officer as he has already been got his cadre changed from Manipur-Tripura to Madhya Pradesh on the grounds of extreme hardship being PH candidate.**

**Case 3:** Proposal of change of cadre in respect of Shri Shiraz Daneshyar, IAS (WB:14) on the basis of OM dated 14/02/2014 regarding cadre change of IAS appointed against vacancies reserved for PH category. (Visually handicapped)

**Case 4:** Cadre Change of Ms K Radhika Aiyar, IAS(WB:11) from West Bengal cadre, on the basis of PH(Physically Handicapped) policy dated 14.02.2014.

**Case 5:** Cadre change of Shri Dhaval Jain, IAS(WB:14) from West Bengal cadre, on the basis of PH policy dated 14/02/2014. (Loco-motor disability)

The Committee after detailed deliberations decided to **defer the proposals at Sl.No.3 to 5 for the time being.**
