

Minutes of the meeting held under the chairmanship of Shri Sanjay Kothari, Secretary, DOP&T on 19.04.2016 to consider the cases of inter cadre deputation/ inter cadre transfer / extension in inter cadre requiring relaxation of provision(s) of the guidelines.

A meeting was held on 19.04.2016 under the Chairmanship of Secretary(P) to consider the cases of inter cadre deputation/ inter cadre transfer / extension in inter cadre deputation period requiring relaxation of provision(s) of the guidelines. The members of the committee EO&AS & AS(S&V) were also present. Further, US(S-III) was also present to assist the Committee in the meeting.

The Committee took note of the Action Taken Report on the minutes of the previous meeting held on 13.04.2016. The Committee after detailed deliberations and careful consideration in each case took following decisions in the meeting:-

Case 1: Extension of Inter-cadre deputation period of Ms. Nidhi Kesarwani, IAS (MN: 2004) from Manipur cadre to Uttar Pradesh cadre

The Committee was informed that Ms. Nidhi Kesarwani, IAS has requested for extension of inter cadre deputation period by further four years. The Committee was also informed that as per existing policy guidelines, lady officers borne in the North East cadres are eligible for inter cadre deputation to other cadres for a maximum period of 9 years with the flexibility to utilize the maximum allowable period in two spells instead of one. The Committee has also taken note of the precedents wherein the ACC has allowed extension of deputation period in different manners i.e. 5+2+2 years, 5+4 years and also 9 years at a stretch. It was also informed that the existing policy of inter cadre deputation for North East cadres is under review. In the revised policy, it is proposed that inter cadre deputation initially be allowed for 5 years extendable to further 2 years at one go. Thereafter, deputation for another spell of 2 more years may be allowed after review. The Committee after detailed deliberations recommended to put up ACC note accordingly.

Case 2: Request for inter cadre deputation of Mrs. S. Chhakchhuak, IAS (GJ:2008) from Gujarat cadre to Assam cadre.

The Committee was informed that Mrs. S. Chhakchhuak, IAS has requested for inter cadre deputation to Assam cadre. **The Committee after detailed deliberation directed to place the precedents before the Committee and deferred the proposal for the present.**
