

**Minutes of the meeting held under the chairmanship of Shri Sanjay Kothari, Secretary, DOP&T on 20/10/2015 to consider the cases of inter cadre deputation/ inter cadre transfer requiring relaxation of provision(s) of the guidelines**

A meeting was held on 20/10/2015 under the Chairmanship of Secretary(P) to consider the cases of inter cadre deputation/ inter cadre transfer requiring relaxation of provision(s) of the guidelines. The members of the committee EO & AS and AS(S&V) were also present.

The Committee took note of the Action Taken Report on the minutes of the previous meeting held on 13/10/2015 and decided to defer the proposal of Shri Shiraz Daneshyar, IAS (WB:14).

The Committee thereafter took the proposals and after detailed deliberations and careful consideration in each case, took following decisions in the meeting:-

**Case 1: Cadre Change of Shri Pawar Narsing Sambhaji, IAS(AM:13) from Assam Meghalaya cadre, on the basis of PH(Physically Handicapped) policy dated 14.02.2014.**

After detailed deliberations, the Committee decided to defer the proposal.

**Case 2: Reconsideration of the proposal for Inter cadre deputation of Shri Ranjit Kumar Singh IAS (GJ: 08) from Gujarat cadre to Bihar cadre.**

The Committee was informed that the State Government of Bihar and Gujarat have conveyed their consent earlier to the proposed cadre transfer. However, the officer has not completed the required 9 years of service in his parent cadre and is not recommended as it is not covered in the policy.

**The Committee directed to reiterate its earlier decision and did not recommend the proposal of the officer and decided to incorporate the case in the quarterly report to be submitted to ACC and officer to be informed about the above decision.**

**Case 3: Inter cadre transfer of Shri Jitendra Kumar Singh, (JK:08) & his spouse Ms Vipra Bhal, IAS (GJ:06) to third cadre i.e. Haryana, Rajasthan or Punjab.**

After deliberation, the Committee decided that the request of the woman officer Ms. Vipra Bhal, IAS (GJ:06) for cadre change from Gujarat cadre to J& K cadre may again be taken up with the State Government of Jammu & Kashmir.

**Case 4: The proposal for regularization of inter cadre deputation period from 21.08.2012 to 30.08.2013 of Shri Ajoy Sharma, IAS (PB:99), the then Joint Secretary Finance, Chandigarh Administration from Punjab cadre to AGMUT cadre (Chandigarh Admn.).**

The Committee was informed that the MHA has requested to regularize the inter cadre deputation period of the officer from 21.08.2012 to 30.08.2013. Further, it was also informed that the process to find replacement of the officer was started well before the completion of the tenure of the officer and during the period of more than one year, panel

received from the Punjab Government were sent to MHA for selection and appointment of an officer to the post. But, due to various clarifications sought by the Ministry, it took more than one year to appoint an officer to the post of JS Finance. MHA should fix the responsibility for overstay of Shri Ajoy Sharma, IAS (PB:99) without the approval of ACC.

**The Committee directed that the MHA may resubmit the proposal with full justification clearly mentioning the officer / authority responsible for such overstay of the officer without approval of ACC.**
