

**Minutes of the meeting held under the chairmanship of Shri Sanjay Kothari, Secretary, DOP&T on 25.05.2016 to consider the cases of inter cadre deputation/ inter cadre transfer / extension in inter cadre requiring relaxation of provision(s) of the guidelines.**

A meeting was held on 25.05.2016 under the Chairmanship of Secretary(P) to consider the cases of inter cadre deputation/ inter cadre transfer / extension in inter cadre deputation period requiring relaxation of provision(s) of the guidelines. The members of the committee EO & AS and AS(S&V) were also present. Further, Director, AIS & US (S-III) were also present to assist the Committee in the meeting.

The Committee took note of the Action Taken Report on the minutes of the previous meeting held on 17.05.2016. The Committee after detailed deliberations and careful consideration in each case took following decisions in the meeting:-

**Case 1:** Request for extension of deputation of Ms. A. Mona Sreenivas, IAS (HY:06) cadre to AGMUT cadre for a further period of two years.

The Committee was informed that Ms. A. Mona Sreenivas, IAS (HY:06) has requested for extension of deputation period for a further period of two years beyond 11.07.2016 on personal grounds. The Committee in the last meeting directed to reconcile her case with her spouse Shri A. Sreenivas, IAS (HY:04) and put up in next meeting. The Committee was accordingly informed that her spouse had sought premature repatriation to his parent cadre Haryana from Telangana cadre due to personal reasons. **The Committee after detailed delebrerations directed to seek the clarification/reasons in writing from the officers.**

**Case 2:** Request for inter cadre deputation of Dr. Parshant Kumar Goyal, IAS (TR:2007) from Tripura cadre to Punjab cadre for five years.

The Committee was informed that Dr. Parshant Kumar Goyal, IAS (TR:2007) has sought inter-cadre deputation from Tripura cadre to Punjab cadre for five years on personal grounds. **Since the case is covered under exiting policy, the Committee after deliberations recommended the proposal and directed to seek comments of State Government of Tripura, Punjab and vigilance status of the officer. Thereafter, on receipt of requisite comments/no objection, the proposal along with ACC note may be put up for the approval of ACC.**
