

**Minutes of the meeting held under the chairmanship of Shri Sanjay Kothari, Secretary, DOP&T on 04.01.2016 to consider the cases of inter cadre deputation/ inter cadre transfer / extension in inter cadre requiring relaxation of provision(s) of the guidelines.**

A meeting was held on 04.01.2016 under the Chairmanship of Secretary(P) to consider the cases of inter cadre deputation/ inter cadre transfer / extension in inter cadre deputation period requiring relaxation of provision(s) of the guidelines. The members of the committee EO & AS and AS(S&V) were also present. Further, US(S-III) was also present to assist the Committee in the meeting.

The Committee took note of the Action Taken Report on the minutes of the previous meeting held on 16/12/2015. The Committee after detailed deliberations and careful consideration in each case took following decisions in the meeting:-

**Case I: Inter cadre transfer of Shri P Vijay Bhaskar Reddy, IAS (Assam – Meghalaya: 2015) on the basis of PH policy dated 14/02/2014**

The Committee was informed that the State Government of Assam (i.e. parent cadre of the officer) has decided not to consider the case of cadre transfer of the officer. The committee after detailed deliberations decided to consider the proposal in case State Government of Assam agreed for the same.

**Case II: Inter cadre transfer of Ms. Nidhi Gupta, IAS(HR:2015) from Haryana to Uttar Pradesh on the ground of marriage to Shri Anurag Vats, IPS(UP:2013).**

The Committee was informed that the officer has requested for cadre transfer to Uttar Pradesh on grounds of marriage to Shri Anurag Vats, IPS (UP:2013). The home state of the officer is Delhi. **The Committee after detailed deliberations decided to seek comments of the concerned State Governments and vigilance status of the officer. Thereafter, on receipt of no objection from the State Governments, the proposal may be put up for the approval of Secretary (P) through EO&AS.**

**Case III: Inter cadre transfer of Shri Sravan Kumar Jatavath, IAS (2014) from Tamil Nadu cadre to Telangana cadre**

The Committee was informed that the State Government of Telangana has requested for cadre transfer of the officer being Telangana a deficit cadre and lack of insiders. Further, as per detailed application form Civil Services Exam, 2013, the home state of the officer is Telangana. **The Committee after detailed deliberations decided not to recommend the proposal of the officer as it is not covered under the extant policy and directed to incorporate the case in the quarterly report to be submitted to ACC.**

**Case IV: Inter cadre deputation of Shri Brahma Deo Ram Tiwari, IAS (AM:06) from Assam Meghalaya cadre to Uttar Pradesh cadre..**

The Committee was informed that the officer has requested for inter cadre deputation on the grounds of ill health of his parents. Further, the officer has completed the required 9 years of service in his parent cadre and has not reached Super Time Scale.

The Committee after detailed deliberations directed to seek comments of the state Governments concerned and vigilance status of the officer. Thereafter, on receipt of requisite comments, the proposal along with ACC note may be put up for consideration and approval of ACC.

**Case V: Extension of inter cadre deputation of Shri Pankaj Yadav, IAS(HY:2001) from Haryana to Uttar Pradesh.**

The Committee was informed that the period of deputation of the officer is going to expire on 14.01.2016. The State Government of UP vide letter dated 22.07.2015 has requested for extension in inter cadre deputation of the officer for further 2 years. Further, the State Government of Haryana vide letter dated 29.12.2015 has also conveyed no objection to the proposed extension of inter cadre deputation period of the officer. **The Committee directed that the proposal along with ACC note may be put up for the approval of ACC.**

**Case VI: Dr. K.H. Govinda Raj, IAS (MH: 95).**

The Committee was informed that Dr. K.H. Govinda Raj, IAS(MH:95) overstayed for a period from 05.10.2012 to 04.09.2013 while he was on inter cadre deputation from Maharashtra cadre to Karnataka cadre. **The Committee after detailed deliberations directed to list out such cases and seek explanation of the concerned officers as per draft Memorandum suggested by AVD-I(B) Division. The explanation so received may be examined and if not found satisfactory then proposal for initiating disciplinary action be considered with the approved of the competent authority.**
