Minutes of the meeting held under the chairmanship of Shri Sanjay Kothari, Secretary, DOP&T on 09/11/2015 to consider the cases of inter cadre deputation/ inter cadre transfer / extension in inter cadre requiring relaxation of provision(s) of the guidelines.

A meeting was held on 09/11/2015 under the Chairmanship of Secretary(P) to consider the cases of inter cadre deputation/ inter cadre transfer / extension in inter cadre deputation period requiring relaxation of provision(s) of the guidelines. The members of the committee EO & AS and AS(S&V) were also present. Besides Dir(AIS) & US(S-III) were also present to assist the Committee in the meeting.

The Committee took note of the Action Taken Report on the minutes of the previous meeting held on 27/10/2015.

The Committee thereafter took up the fresh cases and after detailed deliberations and careful consideration in each case, took following decisions in the meeting:-

Case I: Proposal for extension of inter cadre deputation period of Shri Sanjay Kaul, IAS (KL:2001) from Kerala cadre to Gujarat cadre for further 2 years.

The Committee was informed that the officer has requested for extension for inter cadre deputation for a period of further 2 years beyond 5 years of permissible limit in relaxation of extant guidelines. **The Committee directed that the proposal of the officer may again be put up in the next meeting with all such precedents.**

Case II: Proposal for inter cadre deputation of Shri Shurbir Singh, IAS (AGMU:2004) from AGMUT cadre to Punjab Cadre on personal grounds.

The Committee was informed that the officer is of 2004 batch and has completed required 9 years in cadre and also has not reached supertime scale. The officer has requested for inter cadre deputation on personal grounds. **The Committee directed that the comments of the concerned states may be sought along with vigilance status of the officer with copy marked to the officer. Thereafter, on receipt of requisite no objection / consent, ACC note may be put up for consideration of ACC.**

Case III: Proposal for reconsideration for Inter cadre Deputation of Dr. (Ms) Karuna Kumari, IAS (AM:2010) to Home Cadre Bihar, on compassionate grounds

The Committee was informed that the officer belongs to Assam-Meghalaya cadre and therefore as per OM No. 13017/16/2003 dated 11.07.2006, a lady AIS officer borne on the North East cadres may be allowed to go on inter cadre deputation after completion of 6 years of actual service in the North East. However, the required period of 6 yrs in the instant case is going to be completed in January 2016. **The Committee directed to seek comments of the concerned states meantime with a copy marked to the officer.**

Case IV: Proposal for inter cadre transfer of Ms. Krittika Jyotsna, IAS (AP:2014) now allocated to Telangana cadre to Uttar Pradesh cadre on the grounds of marriage to Shri Rahul Pandey, IAS (UP:2014)

The Committee was informed that the officer belongs to Hyderabad district of erstwhile Andhra Pradesh so her home state is Telangana as per information given by the officer in detailed application form to UPSC. The Committee noted that Shri Rahul Pandey, IAS (UP:2014) belongs to 2014 batch not 2013 as indicated in the application of the officer. The Committee directed to seek the comments of concerned states i.e. Telangana and Uttar Pradesh. Thereafter, on receipt of requisite no objection / consent, the proposal may be put up for approval of Secretary (P) through EO &AS.

Case V: Proposal for cadre change of Shri Prashant Panwar, IAS(JK:2015) from Jammu & Kashmir cadre on the grounds of PH (Physically Handicapped) policy dated 14.02.2014.

The Committee was informed that the officer has requested for cadre change on the basis of PH policy dated 14/02/2014. The Committee also perused the Medical Board Report of the officer. The states contiguous to the home State i.e. Delhi of the officer are Haryana and UP. However, the officer has requested for cadre change to Haryana, Punjab and Rajasthan (in order of preference). Out of which only Haryana is contiguous to Delhi (i.e. Home state of the officer). The Committee "agreed for" the proposal and directed that comments of State Governments of Haryana and UP may be sought and a copy of the letter may be endorsed to the officer. Thereafter, on receipt of requisite no objection / consent, the proposal may be put for the approval of ACC.
