In pursuance to Para 1.2 of Budget Circular 2023-24, discussions to finalise RE 2022-23 and BE 2023-24 in respect of the Grants/Appropriations will commence w.e.f.10.10.2022 under the Chairmanship of Finance Secretary and Secretary (Expenditure). The Pre-budget Meetings in respect of Demands to be chaired by JS (Budget) have been indicated in **bold** in the schedule. The meetings will be held in FRESCO, Room No. 169-D, North Block, New Delhi as per the schedule enclosed.
