

The following Act of Parliament received the assent of the President on the 24th December, 2023 and is hereby published for general information:—

THE APPROPRIATION (No. 3) ACT, 2023

No. 40 OF 2023

[24th December, 2023.]

An Act to authorise payment and appropriation of certain further sums from and out of the Consolidated Fund of India for the services of the financial year 2023-24.

BE it enacted by Parliament in the Seventy-fourth Year of the Republic of India as follows:—

1. This Act may be called the Appropriation (No. 3) Act, 2023. Short title.
2. From and out of the Consolidated Fund of India there may be paid and applied sums not exceeding those specified in column 3 of the Schedule amounting in the aggregate to the sum of one lakh twenty-nine thousand three hundred forty-eight crore and eighty-five lakh rupees towards defraying the several charges which will come in course of payment during the financial year 2023-24 in respect of the services specified in column 2 of the Schedule. Issue of Rs. 129348,85,00,000 out of the Consolidated Fund of India for the financial year 2023-24.
3. The sums authorised to be paid and applied from and out of the Consolidated Fund of India by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year. Appropriation.
