

NOTIFICATION

New Delhi, the 8th September, 2013

G.S.R. 608(E).—In exercise of the powers conferred by sub-section (1) of Section 3 of the All India Services Act, 1951 (LXI of 1951), the Central Government, in consultation with the Government of Tripura hereby makes the following Rules further to amend the Indian Police Service (Pay) Rules, 2007, namely :-

1. (i) These rules may be called the Indian Police Service (Pay) Second Amendment Rules, 2013.
- (ii) They shall come into force from 24.12.2012.
2. In the Indian Police Service (Pay) Rules, 2007 :-
 - (a) In "Schedule II-A – Posts carrying pay above the time scale of pay of the Indian Police Service under the State Government" in the Table, for the entry "Manipur-Tripura" occurring in the first column and the corresponding entries in the second column, the following shall be substituted namely :-
