

OFFICE MEMORANDUM

Sub: Select List of Section Officers' Grade for the year 2006, 2007 and 2008 against Examination Quota on the basis of Combined Limited Departmental Competitive Examination, 2006, 2007 and 2008 held by the Union Public Service Commission.

The cadre unit authorities were requested to ensure that the officers concerned are relieved within 45 days from the date of issue of this OM to take up the new posting in the cadre unit allocated, failing which their appointment/promotion shall be cancelled and the dossier(s) of the candidate(s) concerned returned to the UPSC.
