Subject: Submission of Immovable Property Return for the years 2009
& 2010 – List of defaulting officers of CSS.


Reference is drawn to this Department's O.M. of even number dated 6.1.2011, subsequent reminders dated 11.04.2011, 13.05.2011, 10.06.2011 and 11.07.2011 on the subject mentioned above.

2. Ministries/ Departments are well aware that the Immovable Property Returns (IPR) in respect of CSS Officers (Under Secretary and above level) are required to be furnished to this Division by 31st January of every year. However, despite repeated reminders the IPR for the year 2009 which was to be received in this Division by 31.01.2010 and IPR for the year 2010 which was to be received in this Division by 31.01.2011 have not yet been received in respect of the officers as per Annexure.

3. Ministries/ Departments are, therefore, once again advised to obtain the IPR from the defaulting officers and forward the same to this Department without any further delay.

4. It has been observed that several of the defaulting officers have indicated in their respective APARs that they had submitted their IPR on time, whereas the IPRs have not yet been received in this Division. The Ministries/ Departments should therefore verify the factual position at their end and forward the IPRs to this Division without further delay. In case the statement made in the APARs by officers does not reflect the correct position, suitable action may be taken under relevant rules.

5. Details of action initiated against the officers figuring in the Annexure who have failed to submit the IPRs despite repeated reminders may also be intimated.
