OFFICE MEMORANDUM

Subject: Clarification regarding CGHS empanelled hospitals in Faridabad

The undersigned is directed to invite reference to the Office Memorandum of even number dated 7th October 2010 on the above subject, and to state that this Ministry has been receiving representations from CGHS beneficiaries of Faridabad regarding problems faced by the beneficiaries in obtaining medical facilities, in view of the inadequacy of newly empanelled hospitals and diagnostic centres under CGHS in Faridabad.

2. The matter has been examined by the Ministry of Health & family Welfare and it has accordingly been decided to that the following hospitals , which were empanelled under the previous continuous empanelment scheme , would continue to be treated as empanelled under CGHS, Delhi at old rates of 2006 till completion of two years of empanelment or till they are empanelled under CGHS , Delhi under the current continuous empanelment scheme notified on 19th January 2011:

Sarvodaya Hospital, - Empanelled wef 17.6.2009
QRG Central Hospital & Research Centre Ltd.- Empanelled wef 25.09.2009

3. Diagnostic services which were available at the following centres under the previous tender / continuous empanelment scheme would also be permitted at old rates of 2006 till further orders:
