2. As per Rule 4 of the IAS (Regulation of Seniority) Rules, 1987, the officers whose name have been mentioned at Sl. No. 1 to 5 of the select list of 2010 shall be placed below Ms Renu Phulia, the junior most promotee IAS officer of 2005(on the basis of Select List of 2009A) batch and above Ms. A. Mona Sreenivas, the senior most DR officer of 2006 batch of Haryana cadre.



3. Seniority/year of allotment of officers at Sl. No. 1 in the Select List of 2010 has been restricted in terms of provision to Rule 3(3)(ii) of IAS (Regulation of Seniority) Rules, 1987.

- (v) CWP No.20080/2012 filed by Virender Singh Hooda Vs. State of Haryana & Others before the Hon'ble Punjab & Haryana High Court, Chandigarh.
